
Phase 3- Utility Progression



RETAINING WALL

- Construction on retaining wall to begin mid January
- Construction will consist of soil nail construction, excavations, & installation of retaining wall
- Deliveries for retaining wall will occur through out installation process. Including drilling rig.





STEEL ERECTION

- Steel erection in area's C&D complete
- Steel erection in area B to begin 12/11
- Steel deliveries to occur periodically through out the steel erection phase for area's A&B





SITE CLEANING & DUST CONTROL


Waste Management – Site and Street Cleaning

- Construction Site will implement gravel access roads around perimeter of new building pad to help keep vehicle tires clean
- A tire wash rack system will be utilized at each of the SCE Stabilized Construction Entrances
- Regular street sweeping will be performed to keep mud off the streets
- A water truck is permanently on site to assist in dust control



SITE SECURITY

- Construction Site will have safety/security fencing around the entire perimeter for the duration of construction. This will ensure distinct separation between the jobsite and the adjacent neighborhood
- The site will only be accessible through the designated construction entrance gates
- Site will be monitored by a series of security cameras and intrusion detection systems, currently located at above the WT Field Office.
- Construction Entrances and Field Offices are locked at the end of every work day




