#### CURRENT PROJECT ACTIVITIES

Activity	Status
Exterior Brick Veneer	Install continuing in area Area D. Completion for area D will be mid April
Retaining Wall	Wall installation continuing by old loading dock area. Wall installation complete by mid April
Interior Framing	Complete in areas C&D, ready for 1 <sup>st</sup> coat. WPC Entrance is framed out. Area A Level 1, all framing installed
Roof Install	Roof installed for area's C&D. Roofer to begin installing Roof in area A on 4/6/2020.
Steel Erection	Steel erection is complete. Iron workers are continuing to install stairs in area D

#### **RETAINING WALL**

- Construction on retaining wall beginning 2/18
- Construction will consist of soil nail construction, excavations, & installation of retaining wall
- Final Wall color will be a costal tan stone
- Complete for wall is set for mid April





#### STEEL ERECTION

- Steel Erection complete for entire building
- Iron workers are still on site installing the stairs for area D







#### TIRE WASH

#### WPC/LTM – Tire Wash

- Construction Site will implement gravel access roads around perimeter of new building pad to help keep vehicle tires clean
- A tire wash rack system will be utilized at each of the SCE Stabilized Construction Entrances
- A tire wash station has been installed at the front entrance for all vehicles to wash off tires before leaving the site.



#### SITE SECURITY

- Construction Site will have safety/security fencing around the entire perimeter for the duration of construction. This will ensure distinct separation between the jobsite and the adjacent neighborhood
- Temporary doors have been installed to secure building






- The WPC/LTM Project has change work days to Mon-Thurs. with Friday being a make up day for weather
- Whiting-Turner has doubled the temporary toilets on site and they are now cleaned daily
- Additional hand washing and hand sanitizing stations have been install on site
