### IN GENERAL

IAC staff continues to work either from home or from the office / field per the orders of the Governor and the requirements of the work, with no disruptions to report.

### MOU §1. ROLES, RIGHTS AND RESPONSIBILITIES

IAC staff attended recent feasibility study team meetings on Commodore John Rodgers PK-8, as well as on High School Plan projects: Frederick Douglass HS / Joseph Briscoe Special Education Center and Baltimore City College HS. In addition, staff attended a lessons-learned retreat with representatives of all Partners.

### MOU §4. IAC AND BPW PROCESSES

IAC staff reviewed the educational specifications (ed specs) for the Frederick Douglass HS / Joseph Briscoe SE renovation project, and then met with Partners to further discuss the projected enrollment for both programs, the spatial needs of the proposed CTE programs at Frederick Douglass HS, and the spatial needs of the (LRE-F) special education program at Joseph Briscoe SE. Enrollment is used to determine the gross area baseline (GAB) applicable to the project, which indicates the gross square feet (GSF) limit of State participation in school construction projects. At this time, staff does not concur with the proposed enrollment of 991 students, and cannot support State funding for the proposed enrollment.

IAC staff reviewed the ed specs for the City College HS #481 renovation project, and then met with Partners to review the projected enrollment for the program. At this time, staff concurs with a proposed enrollment of 1,902. The ed specs call for 296,730 GSF, which is around 4,200 GSF (or 1.5%) more than the GAB for the proposed.

IAC staff received the ed specs for the Commodore John Rodgers PK-8 replacement project, and will consider the proposed enrollment to determine concurrence within the next two weeks.

**Current Status:**

➤ **Year 1 Schools**

- Ten of the eleven Year 1 schools are open and occupied.
- Patterson/Claremont construction continues. Roofing is substantially complete. Brick facade is complete, and installation of metal panels and windows are ongoing. MEP rough-ins are ongoing throughout the building and drywall installation has begun in areas where MEP rough-ins are complete. Completion of the new building is scheduled for Summer 2021.

➤ **Year 2 Schools**

- Five of the seventeen Year 2 schools are open and occupied. (Fairmont Harford, Bay Brook, John Ruhrah, Calvin Rodwell and Mary Rodman)
- Walter P. Carter/Lois T. Murray construction is nearing completion. Site finishes and sod are being installed with conversion of SWM ponds commencing. Building superstructure is complete. Interior finishes are nearing completion with final cleaning taking place behind final touch up. Permanent water, gas and electric are complete. System commissioning is nearing completion. Scheduled for a January 2021 opening.
- Govans construction continues. Steel erection is ongoing and scheduled to be completed by mid-December. Elevated deck pours have begun. Metal framing has started on the first floor, along with MEP rough-ins. Scheduled for a summer 2021 opening.
- Medfield construction is nearing completion. Interior punch list finishes, painting and miscellaneous work is in progress, along with final cleaning and floor waxing. Site work is 99% complete. Security system surveillance camera installation is nearing completion. Scheduled for a January 2021 opening.
- Harford Heights construction continues. Addition area A interior framing and MEP rough-ins complete, exterior sheathing is essentially complete, exterior brick installation in progress. Existing building 1st floor MEP rough-ins complete, walls closed in, ceiling grid and VRF cassettes installed and prime painting in progress. MEP rough-ins, drywall, ceiling grid, window, VRF cassette installation are in progress in the remainder of the building. Scheduled for a summer 2021 opening.
- Calverton construction continues. Interior framing and MEP rough-ins are in progress in the Classroom wing and exterior framing is nearing completion. Steel erection, block walls, metal decking and concrete pours continue in the remainder of the building. Slab on grade for the Gym wing is complete and block walls are nearing completion. Site utility and water line installation continues. Scheduled for a summer 2021 opening.
- Cross Country – Currently in process to revise the scope of the project to a replacement building built to address 500 year flood plain issues. Pending EAP amendment approval, construction is expected to commence in late Fall 2021 with completion of the new building in summer 2023.
- James Mosher construction continues. Interior and exterior demolition work and new addition steel framing is complete. Cafetorium steel framing and decking, interior wall framing and blocking and MEP rough-ins are progressing. Roofing and exterior façade work started in late September. Scheduled for a summer 2021 opening.
- Robert Coleman construction continues. Interior and exterior demolition work is nearing completion and interior framing is progressing. Drywall, insulation, MEP

rough-ins and new utility installation is proceeding. Scheduled for a summer 2021 opening.

- Northwood construction is underway. The building pad is on grade and footings and slab on grade concrete work continues. Masonry for the gym walls will begin next week. Steel erection will begin at the end of December. Underground utilities are being installed. GMP 2 is currently scheduled to be presented to MSA's board on December 1, 2020, and BPW on December 16, 2020 with a winter 2021 opening.
- Montebello – Montebello design continues. The 50% Construction Document submission was received in early September and has been approved. The 90% Construction Document submission was submitted in mid-November and is currently under review. GMP-1 covering site fencing, demolition and abatement is currently out for bidding. MSA Board and BPW approval is anticipated in January 2021 with construction starting in early February. Scheduled for a summer 2022 opening.
- Highlandtown 237 – The Concept and Schematic Design have been submitted and have been approved. and is currently under review. The 50% Design Development submission was submitted on November 20, 2020 and is currently under review. The 100% Design Development submission is due in mid-December. Scheduled for a summer 2022 opening.

**INTRODUCTION**

Fifteen of the 28 school buildings approved under the program are complete. Of the 13 remaining, nine are under construction, three are in various stages of design development through pre-construction, and one is in the feasibility/planning phase. Between now and summer 2021, eight buildings will be completed, making the program substantially complete, with only five remaining in Plan Year 2.

**SCHOOL BUILDING PLAN AMENDMENTS**

City Schools reviews and modifies the plan yearly to reflect any necessary updates as part of its annual portfolio review process, now called the Annual Review of Schools (Annual Review). Multiple constituents were briefed on the recommendations and proposed amendments to the 21<sup>st</sup> Century School Buildings Plan on October 26, 2020. These were also presented at the November 10, 2020 meeting of the Baltimore City Board of School Commissioners and are scheduled to be voted upon on January 10, 2021. The table below shows the recommendations and proposed amendments and, when approved, will be reflected in the revised Exhibit 6.

**FEASIBILITY STUDIES**

All Plan Year 1 feasibility studies are complete. Of the Plan Year 2 studies, the Commodore John Rodgers E/M plan was kicked off on October 27, 2020. Site visits and community meetings are in progress to guide the preliminary layouts, which are scheduled to be completed this winter.

The high school program is in progress. City Schools’ leadership team is playing a proactive role in guiding the preliminary layouts and scope of each individual school. This is being done to provide a lens of equity balance between the recommended Ed Spec Program and cost, and to maximize (as much as possible) the spread of the \$400-million anticipated under the Built to Learn Act, across the school buildings identified.



City College

1. Both **City College** and the **Frederick Douglass High School** and **Joseph C. Briscoe Academy** co-location at the Frederick Douglass building are progressing. Development of Ed Spec “test-fit” concept schemes continue. Meetings have been scheduled through January 2021 to facilitate the completion of the preliminary designs and pricing proposal before the legislative session.
2. **Western High School** and **Baltimore Polytechnic Institute** are scheduled for project kick-off in December as the procurement process nears completion. The RFP for services was received, the A/E selection has been concluded, and the MSA is scheduled to approve the design teams at its next board meeting in December. Pending approval and Notice-To-Proceed, meetings will be scheduled.
3. **Vivien T. Thomas Medical Arts** co-located with **Bluford Drew Jemison STEM** at the Francis M. Wood building, and the **Edmondson-Westside** school have not yet started. Draft Ed Specs are pending.

## UTILIZATION RATES/SURPLUS

No current update.

## STAFFING UPDATES

The 21<sup>st</sup> Century School Buildings Program office currently has one active vacancy:

- The **Senior Utilities Manager** was replaced with a **Director of Engineering & Construction** position as we were not attracting qualified personnel. The position is currently being advertised.

## FINANCE UPDATE

The operations appropriations request of \$5,977,327 approved by the Board of Commissioners received MSA approval on October 8, 2020 in the revised amount of \$5,848,841. This includes reductions in reimbursable salary, travel, SchoolDude renewal, and some engagement costs.

## DESIGN & CONSTRUCTION

Multiple submittals for projects in design and under construction were completed. Quality control walk-throughs are ongoing for the mid-year deliveries of Medfield Heights and Walter P. Carter/Lois T. Murray. Building orientations for principals and staff have been scheduled for December and include key turnover.



The 21<sup>st</sup> Century School Buildings Team along with City Schools participated in a MOU Partners Retreat on October 21 and 22 with the MSA, IAC, and Baltimore City to perform an in-person tour of Fort Worthington and The Reach! Partnership School in the Fairmont Harford building. The teams reviewed progress to date, challenges, opportunities, and lessons learned since the inception of the Program. The feedback from the retreat will be used as a catalyst to initiate design changes in future buildouts.

## FURNITURE, FIXTURES & EQUIPMENT (FF&E) ASSET MANAGEMENT

The team is currently coordinating the delivery, barcoding, and installation of FF&E items for Medfield Heights and Walter P. Carter school buildings. They are scheduled to be open on January 4, 2021.

## TECHNOLOGY

Most of the end-user technology devices for Medfield Heights and Walter P. Carter school buildings have been received for delivery and installation. A few items on backorder for Mary E. Rodman have been received and installed. Professional development sessions for staff are being held virtually, where needed.

## 21<sup>st</sup> CENTURY ACADEMIC PLANNING

No current update.

## CURRENT SWING OCCUPANCY

At present, nine schools are in swing locations. Coordination is in progress for two schools to relocate during the 2020-21 winter break.

1. Medfield Heights will relocate from the Chinquapin building to its permanent school building
2. Walter P. Carter will relocate from the Winston building to its permanent school building.

## WORKFORCE DEVELOPMENT/ BACKGROUND CHECKS

As of November 13, 2020, **7,722** fingerprinting/background clearances had been performed. Of these:

- 7,375 - cleared
- 347 - not cleared

Since re-opening on July 6, 2020 by appointment only, **623** fingerprinting/background clearances have been performed for critical hires that were employed under the “temporary work-around process.” Of these:

- 595 - cleared
- 28 - not cleared

## COMPREHENSIVE MAINTENANCE PLAN HIGHLIGHTS

## 21<sup>ST</sup> CENTURY STUDENT INTERNSHIP PROGRAM

In lieu of an onsite “hands-on” experience in offices and on project sites, 2020/2021’s partnership with Urban Alliance (UA) will proceed with a hybrid (virtual and in-person) training model for students. This includes “**Operating in a Post-COVID-19 Workplace**” and “**Transition to Worksites Plan**” to benefit students and mentors. This paid remote internship/training will include intensive skill building in digital literacy (e.g., G-mail suite, presentations, and hosting virtual meetings), a national speaker series, and online mentoring. Recruitment is through December 2020, and the work period will be from February to July of 2021.

## COMMUNITY ENGAGEMENT

The Engagement Team completed 42 virtual community meetings with over 900 attendees and continues to schedule community meetings utilizing GoToWebinar as its platform. Engagement continues to actively work with principals at merging schools and engage students and families virtually. Additionally, the team is coordinating principal and project tours of schools in different phases of design and construction.
