- MBE report In year two schools that the move in and relocation line was added for Frederick, the Frederick Douglass Briscoe contract.
- On our change order report, you will just notice that this is mostly closeout data from schools that are in their closeout process.
- For workforce development since our last meeting, we have completed Montebello Elementary/Middle. And it has successfully completed all its workforce development requirements and it has been added to our list as well as Northwood.

## **Collaborative Group Report: Daral Falls**

- 10 resumes received from our workforce partners from Civic Works, 3 from Job 3 from Jumpstart.
- 119 job orders that have been posted through (Mayor's Office) of employment development.
  - Amounts to 277 actual job positions,
  - 118 hires with an average salary of 25.04.
- We are continuing to host by-weekly prescreening for construction and apprenticeship opportunities.
- Awaiting commencement of Commodore Rodgers and Brisco so we can start to me with the CM's.

## Financial Reports: Larry Lynn, MSA

- See Report to the Executive Committee.
- Revenues 2020 FY23 was a good year. Approximately 15.1 million greater than budgeted, primarily due to an investment income.
- Expenditures were 55.4 million under budget.
- Contractual services were 38.9 million under bud or for the year.
- Fixed charges were under budget by 19.1, we lost a little bit on the final tax proceeds based on previous year over payments.

## MSA: Lary Flynn

- Ribbon cutting for Cross Country on December 13th and the kids return to the building from Northwestern on January 6th to start up the second half of the school year.
- Year 1 schools: 11 are constructed, they are open and occupied.
- Year 2 schools: 16 schools of the 17 which house 18 schools are open and occupied
- Commodore John Rodgers, 50% construction documents submission has been made to MSA and City Schools, 90% is scheduled to be submitted during the week of April 15th and the 100% by May 20th.

- Year 3: Douglass Briscoe 50% Construction documents was submitted on Jan. 31<sup>st</sup> 90% on March 20 for review and the project projected Summer 2026 opening.
- Current procurement for Commodore John Rodger CM services and the Frederick Doughlas improvements. Upcoming procurements Commodore John Rodgers and Frederick Douglass testing and inspection.

## 21st Century Program: Cyndi Smith, City Schools

- New Cross Country Elementary school did open in January as the 27th of the 29 school buildings in the 21st Century program.
- Southeast building surplus date has recently been updated to be 2026 because of Commodore John Rodgers new opening date.
- SY 2023-24 utilization based on our official enrollment for September 30th is projected to be 87%.
- Design continues at Commodore John Rodgers and on Douglass Briscoe.
- We continue to provide AV IT support technical support as well as academic support.
- One school in swing and one school moving into swing.
- Next school to move to swing space will be happening this summer, so this summer we are moving Frederick Douglass into the Northwestern building for the next two years.
- We have submitted our scope of repairs for the Northwestern Building and MSA and City Schools is working on that on each of their respective sides to be able to have that ready for Frederick Douglass
- The Cross Country ribbon cutting was amazing as always and we will continue with our engagement activities throughout this year including the swing logistics for Frederick Douglass to make sure that that goes smoothly.

## Introduction

As of February 2024, twenty-seven of the twenty-nine school buildings approved under the 21st Century School Buildings Program are complete. The new Cross Country Elementary/Middle School building opened in December 2023 as the 27<sup>th</sup> completed building of the 21<sup>st</sup> Century Buildings Program. Of the two schools remaining, Commodore John Rodgers Elementary/Middle School started design in late September 2023 and is planned to open in Summer 2026. Additionally, the co-locating schools of Frederick Douglass High School and Joseph C. Briscoe Academy Middle/High School (Douglass-Briscoe School) have been added to the 21<sup>st</sup> Century School Buildings Program. The design for this project started in February 2023 with a planned opening in Summer 2026. Frederick Douglass High School will move into the Northwestern Building in Summer 2024 and will stay at this swing location until the newly renovated Frederick Douglas Building is completed. In March 2024, work will begin to prepare the Northwestern Building to house Frederick Douglass High School for the next two years.

## **Feasibility Studies**

Feasibility studies are complete for City College High School and Baltimore Polytechnic Institute-Western High School.

## **Utilization Rates/Surplus**

City Schools' citywide enrollment for the SY 2022-23 school year was 75,995, and the utilization was 86%. The official enrollment for SY 2023-24 is 75,811, a decrease of 0.2% from the previous school year. The SY 2023-24 utilization based on official enrollment for September 30, 2023, is 87%.

## **Staffing Update**

The City Schools 21st Century Office currently has two vacancies:

- Manager Engineering & Operations
- Senior Program Coordinator Community & Engagement

All positions are currently advertised on the Baltimore City Schools website.

A new Baltimore City Schools student intern started at MSA in February and will complete an 11-week internship.

## **Finance Update**

The 21st Century Buildings Program submitted its proposed Fiscal Year 2024 budget to the

Baltimore City Schools Board of Commissioners at the end of March. The Board has allocated a budget of \$3,838,668.00, which was approved in May 2023. With the changing landscape of the department, a supplemental request will not be submitted for fiscal year 2024.

Planning for the Fiscal Year 25 budget is underway and the estimated amount is \$3,059,079.00. It is anticipated that a supplemental request for funds will not be needed for fiscal year 25.

## **Design & Construction**

The Design Office team (Design) continued its thorough review and processing of construction submittals and field RFIs for in-house technical evaluation, focusing on the Cross Country Elementary/Middle School (#247) replacement project and Phase II of the Highlandtown Elementary/Middle School (#237) renovation project. Both projects adhere to established standards.

Design remained engaged with Commodore John Rodgers Elementary/Middle School (#27), which recently completed the 100% Design Development (DD) phase and moved on to the 50% Construction Drawings phase. Additionally, Design completed a review and comment of the Douglass - Briscoe project Concept phase and moved on to the 100% Schematic phase submission. Design in collaboration with MSA and AE partners is working to ensure the seamless closeout of record documentation for all 21st-century School projects.

## Furniture, Fixtures & Equipment (FF&E)

The Design Office team (Design) continued its support of the Program. The Design staff participated in the Cross Country Elementary/Middle School (#247) walk-throughs prior to its occupancy in January 2024, ensuring building construction compliance with the intended design. Support also included review of project close-out documentations submitted by the AE, CM and other subcontractors.

Throughout the months of January, February and March of 2024, Design remained engaged and will continue its design management oversight of Commodore John Rodgers (CJR) Elementary/Middle School (#27), which recently completed its 50% Construction Documentation (CD) phase and moved on to the production of 90% Construction drawings and specifications.

In February, Design completed a technical review of Frederick Douglass High School and Joseph C. Briscoe Academy's (FDB) 50% CD submission by the A/E team. By way of conducting an in-house QA/QC check, Design asked for an interim submission of various Architectural & Engineering disciplines to ensure documentation of key design elements are complete and to the highest professional standards prior to proceeding with the production of the 90% CD submittals. Design anticipates receiving 90% CD submissions for both CJR & FDB projects in March 2024. Design is fully engaged with both MSA and the AE team in the design management/oversight of Baltimore City College – Built-to-Learn Program. This renovation and addition project is currently in the initial design phase. Design anticipates the completion of Conceptual Design options in late March 2024, followed by the development of Schematic Design in the April-May timeframe.

## Technology

The 21st Century Schools Technology Team continued the design, procurement, and plan installation of technology packages for the two projects under construction including Commodore John Rogers Elementary/Middle School and Frederick Douglas High School. Technology end-user devices for Cross Country Elementary/ Middle School were delivered and installed. An onsite computer technician is supporting Cross Country EM for 6 months after opening in January 2024.

21st Century Schools technicians continue to provide AV/IT technical support services as needed to schools that remain under warranty. After the warranty period ends, technical support will be provided by the City Schools Office of Information Technology Support Services. A Technical Support Transition Guide will be shared with school leadership at all 21st Century Schools under warranty and is posted on the City Schools Teacher Support Services portal page for ease of access. This guide provides school leadership staff with the tools needed to manage technology as identified by City Schools Office of Information Technology's current policies and procedures and to identify school-wide expectations for instructional technology integration to enhance teaching and learning.

## 21st Century Academics

The 21st Century Academics team continued to support 21st Century Schools with the implementation of their identified academic approach. This support included the development, implementation, and review of their academic work plans; the coordination of professional learning aligned to their academic approach; and the facilitation of job-embedded learning experiences focused on instructional technology. During this quarter the team worked very closely with the following schools on the implementation of their academic approach.

## **Swing Locations & Logistics**

Currently, there is one school in a swing location:

- Commodore John Rodgers: Southeast Building, June 2023 through June 2026
- The next school to relocate to swing space is:
  - Frederick Douglass High School: Northwestern, June 2024 through June 2026

Cross Country Elementary/Middle School (#247) relocated into the new Cross Country 21st Century Building in December and when students returned from the winter break; the students and staff started the remaining school year in the new building. The planning for the relocation of Frederick Douglass High School (#450) into the Northwestern building started in December 2023. The Northwestern building will provide the high school spaces that are required and the athletic fields for the numerous sports teams. The team is working on what updates the swing space building will need prior to the relocation of Frederick Douglass in the summer of 2024. Baltimore City Schools and MSA walked the swing space and Baltimore City Schools drafted a scope of work for repairs to the existing Northwestern swing space. The approved scope of work was completed and distributed the end of February. MSA has approved the selected move vendor and the award of the contract has been provided.

We are working to compare the existing Northwestern swing space building furniture and the existing furniture in the Frederick Douglass building to determine what furniture will need to be relocated from Frederick Douglass.

We continue to work with all departments within Baltimore City Schools to determine what resources will be needed for Frederick Douglass to ensure a successful relocation into swing space.

We continue to review and prepare the close out process for the schools that have been relocated. This includes any furniture vendor contracts and any move vendor contracts.

## 21st Century Student Internships

21st Century School Buildings Program, in collaboration with City Schools Office of College and Career Readiness (CCR), Urban Alliance and Maryland Stadium Authority (MSA), is planning its 2024/2025 student internship program. The internships will provide educational and training opportunities related to the work of the 21st Century School Buildings Program. We have conducted several working sessions to determine a new plan for supporting the student internship program. The plan is currently underway and intern pairings are being assessed with construction projects. Funding has been secured and once mentors have been assigned students will begin work. Interns will work up to 12 hours per week Monday-Thursday, during the school year. They transition to 32 hours per week Monday-Thursday, in June and July. Interns continue Urban Alliance professional development sessions on Fridays throughout the year.

## **Community Engagement**

On December 7, 2023, the engagement team hosted a design workgroup meeting for the Commodore John Rodgers Elementary/Middle School Stakeholders at the nearby Holy Trinity Russian Orthodox Church.

On December 15, 2023, the engagement team supported the Cross Country Elementary/Middle School Ribbon Cutting activities. The team also hosted and led building tours that followed in the days after the building's opening.

## **Communications**

The communications team continued to provide writing, graphic design, and coordination support for a wide range of activities, such as website management, social media, newsletter production, photo collection and archiving, time capsules, internal and external meetings, swing space updates, and public events. The following is a summary report of communications activities from this quarter.

## **Events**



Cross Country Elementary/Middle School, located in the Park Heights community, received a replacement to the original building – including three new play spaces, a multisport court, an outdoor classroom, collaborative learning spaces, science and technology classrooms, as well as visual arts and music classrooms. The building was designed with emphasis on community space, built to maximize daylight into instructional areas and provide clear sightlines of adjacent spaces. On December 13, 2023, over 250 community leaders, students, and staff gathered at Cross Country Elementary/Middle School to commemorate the reopening of the school and receive tours of the new construction. With several students and families identifying as English learners, 21<sup>st</sup> Century School Buildings Program and City Schools were able to provide Spanish translation during the program as well as on tours.

The program opened with remarks from Dr. Sonja Santelises, City Schools CEO, followed by LaShella Stanfield, Cross Country Elementary/Middle School Principal, Ahmad Holloway, 8<sup>th</sup> grade student, Maria Jose Nino, 5<sup>th</sup> grade student, Craig Thompson, Chairman, Maryland Stadium Authority, Alex Donahue, Executive Director, Interagency Commission on School Construction, Brandon Scott, Baltimore City Mayor, Sandy Rosenberg, Maryland State Delegate, Isaac "Yitzy" Schliefer, Councilman, Nick Mosby, Baltimore City Council President, Ronald S. McFadden, Board Chair, Baltimore City Board of Commissioners, a performance by 40 students from the Cross Country Elementary/Middle School band led by instructor, Anthony Thompson-Shaw.

### **External Communications**

This fall, communications supported a swing space update meeting for Baltimore Polytechnic Institute and Western High School, a community meeting at Commodore John Rodgers Elementary/Middle School, two design engagement focus groups and a community meeting at Frederick Douglass High School. A summer newsletter came out at the end of August with a spotlight on summer learning, an interview with the architects for the Frederick Douglass Building, and our upcoming events this fall. ## **Social Media Metrics**

Our social media focused on reacclimating 21st Century stakeholders into the first semester of the SY23-24 school year with up-to-date information about their school's project. We saw 7.7K accounts



reached on Facebook, 2.8K impressions on Twitter, and 40 followers gained on Instagram. The Instagram reel feature continued to be a great tool for engagement, and construction updates for Cross Country Elementary/Middle School ramped up anticipation for the December ribbon cutting.

We were also able to provide information for upcoming community meetings at various schools, and relay important updates on project statuses to our stakeholders. In return, we have seen our followers interact in the comments or the direct messages to ask questions and share their thoughts related to their school's project.

## Most Engaging Posts

All accounts saw a revival in engagement as stakeholders reconnected with their school communities. A recap reel of Commodore John Rodgers Elementary/Middle School's first day at their swing space received over 2,209 plays, 115 likes, and 88 shares. Additionally, a Cross Country Elementary/Middle School construction photo compilation received 56 shares.

## **Other Activities**

As the program neared completion for Cross Country Elementary/Middle School, we focused on preparing stakeholders for the new building. This included construction updates across all social media platforms, community meeting invites, and ribbon cutting promotion.

We also followed up with our 21<sup>st</sup> Century Learning Team at Cherry Hill Elementary/Middle School as Rob Glotfelty and Jenna Adams hosted teachers for a classroom technology training. From that informative session, we were able to create an Instagram reel highlighting all the features that a 21<sup>st</sup> Century classroom has to offer. The training would go on to inspire an article in our winter newsletter about classroom technology.
