





- Early sitework utilities | September 2016
- Foundation & structure | March 2017
- Roof construction | May 2017
- MEP equipment & installation | August 2017
- Interior finishes | November 2017
- Sitework | September 2017
- Closeout | December 2017
- School Opening | January 2018

#### **Project Sequencing**

MDE Controls & Site Grading


- Control surface water run-off
- Wheel wash for truck exit
- Periodic street sweeping
- Sidewalk closure

#### Hazmat Abatement

- Signage and community notifications
- Waste bagged and removed from site regularly

Building Demolition & Selective Demolition

- Building demolition by heavy equipment (noise)
- Materials separated on-site; removed daily
- Coordinate hall routes
- Water used to control dust



#### **Project Sequencing**

#### Site Utilities

- Stormwater
- Sanitary
- New electric, gas and water services
- Building pad prep

## Building Construction

- Excavation
- Rammed aggregate piers / soil stabilization
- Foundations / structure
- Building skin and enclosure
- Interior finishes

#### Site Controls


- Continued wheel wash stations at construction entrances
- Periodic street cleaning

### Sitework


- Site demolition
- Site retaining structures
- Hardscape / landscape




#### **New School**



## Parking

- Trade parking will be off-street around project site
- Overflow trade parking will be on-site
- Goal is to limit contractor parking within the neighborhood



#### **Construction Traffic**



#### Waste Management

- Centrally-located dumpsters
- Frequent dumpster pulls
- Daily cleanup by each trade contractor
- Designated eating area
- In concert with Rodent Control Plan



#### **Rodent Control**

- Licensed exterminator surveys existing school site
- Development of comprehensive Rodent Control Plan in concert with Schafer's Waste Management Plan
- Products will be deployed around the site within fenced areas
- Conduct post demolition site survey and review for plan adjustments
- Continually deploy product throughout construction
- Exterminator will monitor site and replenish as needed



#### Security & Work Plans



## Site Security

- Perimeter 6' high chain link fence and locked gates
- Construction signage around perimeter fence
- After-hours security personnel
- Site-walks closed around perimeter for pedestrian protection

## Work Plan

- Work hours | 6:30AM 4:30PM
- Pre-construction meetings all trades
- Mandatory worker orientation
